The school undertakes to abide by the provisions contained in the affiliation & examination bylaws, directions issued from time to time and the law of the land.

a that, the school will ensure compliance of all statutory requirements like EPF, St and Labour Laws etc. with respect to the school and staff of the school.

That, the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

- 11. That, the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
